



Access Guidelines

If anything outside of what is noted below arises during The Praxis of Possibility micro-residency, Leelee Oluwatoyosi will be available on-site as a dedicated listener and support changes that need to be made to best facilitate these access guidelines:

- The Winchester Street Theatre is currently not accessible. The micro-residency is scheduled to occur in Studio B of Winchester Street Theatre, which is located on the basement floor of the building. There are approximately 25 stairs to gain access to the Studio. Please note that once we review the applications, if selected candidates have expressed stairs as an access barrier to participating in the residency, we have an alternate location in place that is accessible.
 - There are 4 steps outside of the front entrance, a small platform, and then 4 more steps to the door of the lobby (a straight hallway that then leads to the next staircase). The door will be propped open for when attendees arrive each day. To head downstairs, there are 5 steps down, a small platform, and then another staircase with 11 steps.
 - To reduce the number of stairs, please notify Leelee or email info@tdt.org in advance, and a staff member can open the fire exit door for you, which opens onto the small platform before the staircase to the basement. There are 2 steps outside of the fire exit door.
 - At the bottom of the staircase, you would turn around the corner to enter the studio. There are washrooms available in the basement that are not accessible and are just past the studio. Gender Neutral washroom signage will be present for the micro-residency.

COVID-19 Protocols

Things to be aware of when attending in-person activities:

- *Vaccinations:* TDT has implemented a mandatory COVID-19 vaccination policy as of September 22, 2021. All patrons, artists and staff are required to be fully vaccinated and must show proof of vaccination along with valid I.D. when attending or participating in a program. Please carefully review the policy for full details.
 - Attendees are required to show proof of vaccination every time they visit for an in-person program, as health information cannot be stored.
- *COVID-19 Screening Check:* In addition to showing proof of vaccination, patrons are required to complete the COVID-19 screening form prior to attending a program in person and present it to staff member upon arriving. This has to be completed each day you visit the building.
- *Face Coverings:* Patrons and staff are required to wear masks at all times. Even if you are vaccinated, you are still required to wear a face mask that covers your nose, mouth and chin.
- *Sanitation:* There is a hand sanitizing station when you enter the lobby at the Winchester Street Theatre. There is also a sanitizing station in every studio within the facility.
- *Reduced Contact:* As much as possible, interactions between TDT staff and patrons will be contactless. This includes ticket scanning and box office transactions.
- *Physical Distancing:* Signage and/or markers will be in place throughout the Winchester Street Theatre and its studios to encourage physical distancing when possible.

Please do not attend an in-person event or class if you have a fever or are experiencing any other symptoms of COVID-19, have tested positive for COVID-19 within 14 days of attending, or have been in close contact with someone suspected or confirmed of having COVID-19.
